Monthly Meeting of April 19, 2021

Call to Order: Chairperson Dennis Graf called the monthly meeting of the Meeme Town Board to order at 6:30 p.m. on April 19, 2021 at the Meeme Town Hall. Notice of this meeting was posted at the four posting locations located at the end of the minutes.

Minutes: The minutes from the March 2021 meeting were read and reviewed. A motion to approve the minutes as written was made by Robert Christian and seconded by Henry Langenhahn. Motion Carried.

Treasurer's Report: Treasurer Susan Kracht presented the Treasurer's Report. A motion to approve the treasurer report as presented was made by Henry Langenhahn and seconded by Robert Christian. Motion Carried.

*Sue reported a certified letter was returned unopened. It was for unpaid personal property taxes amounting to less than \$200. It was agreed it did not pay to proceed legally with this.

Clerk's Report: *We received a report of the results of the groundwater testing. No issues were found. Lemmenes was not able to test the west well as it needed adjusting. Dennis and Pete have since fixed this well. Val will contact Lemmenes to test it.

*The results of the April Election were presented and oaths have been taken

*Annual meeting is April 20 at 7:00. Food has been ordered from Smiling Moose and beverages have been purchased. Thank you to Cleveland State Bank and Rural Mutual for providing the food and beverages.

*A resolution was signed to no longer publish election notices in the newspaper due to the cost and no papers are published in the Town of Meeme

Constable Report: None

Thank you to Bob: As this was Robert Christian's last meeting as Supervisor, a plaque was presented to him for his past service.

Schaeffer Lubricants: A representative from Schaeffer Lubricants presented their products. We are currently contracted with the local co-op, but may look into them at a later time.

Building Permits: Henry reported he issued 5 building permits, including one for a new house

Plan Commission: None

Roads & Equipment: Schmidt is in the process of cleaning ditches on South Cleveland and Lange roads.

*The culvert on Point Creek Rd will need replacing. A permit will need to be obtained from the DNR and we are proposing a 60'x5' plastic culvert.

Buildings: Todd Graf will install a larger drop box at the town shop that will go through the wall and have the receptacle on the inside.

Recycling & Transfer Station: Jim reported there has been a lot of aluminum and iron dropped off recently. He brought up the scheduling of the recycling center for the Saturday before July 4th and Christmas and New Year's which both fall on Saturday. The plan is to be open on July 3rd and we will go over our alternatives at a later date for Christmas and New Years.

Valders Ambulance Service The cost increase will be reported at the Annual Meeting

Smiling Moose: A motion was made by Robert Christian and seconded by Henry Langenhahn to approve the request from Smiling Moose to have outdoor bands in their fenced-off back area from June 1 to October 30. It was noted to limit the time limit to be 10:00 pm. Motion carried.

Fire Departments: Dennis has received complaints from residents and local fire departments of the handling of the recent fire on South Cleveland Road. Fire departments from south of Sheboygan were called to assist before departments that already service Town of Meeme such as Cleveland and St Nazianz.

*We received a request from the Roman Nowaratsky family to place a memorial bench in front of the Town Hall. Mr Nowaratsky was Town Treasurerer for many years. Dennis will get more info about the bench and a decision will be made next month.
