



**MINUTES**  
**Monthly Meeting of September 20, 2021**

**Call to Order:** Chairperson Dennis Graf called the monthly meeting of the Meeme Town Board to order at 6:30 p.m. on September 20, 2021, at the Meeme Town Hall. Notice of this meeting was posted at the posting locations located at the end of the minutes.

**Jamie Aulik and Dick Isley from the City of Kiel** presented the upgrade to the Kiel Paramedic service and what the Kiel Ambulance service could offer us. They indicated the cost would be \$3.25 per capita.

**Minutes:** The minutes from the August 2021 meeting were read and reviewed. A motion to approve the minutes as written was made by Susan Kracht and seconded by Henry Langenhahn. Motion Carried.

**Treasurer's Report:** Treasurer Kathleen Dineen-Grube presented the Treasurer's Report. A motion to approve the Treasurer's report as presented was made by Susan Kracht and seconded by Henry Langenhahn. Motion Carried.

**Clerk's Report/Correspondence:** \*Val is registered for virtual WTA Fall workshops in September. Kathleen will register also.

\*A verification was signed for the Valders Ambulance Service verifying that we use them which is needed for a grant they are applying for.

\*The cooperative Agreement with Manitowoc County Recycling was continued and signed.

\*Levy Limit is currently set at \$336,712. Val will contact the DOR regarding the \$43,000 of debt service which was paid up in 2020.

\*The county notified us that Cty XX was moved into the 5 year construction schedule

**Constable Report:** The constable followed up on two dog licenses.

**Building Permits:** Henry reported he issued 5 building permits.

**Plan Commission:** A motion was made by Susan Kracht and seconded by Henry Langenhahn to approve the recommendation by the plan commission to rezone 10 acres and grant a conditional use permit to Daniel and Katherine Kleinhans for an event barn on their property on Spring Lake Rd. Motion Carried.

**Roads, bridges & Equipment:** \*Matt Schneider and Pat Schneider aired concerns of traffic on Mineral Springs Road during Siemers' construction project. They suggested changing where the temporary signs will be located and temporarily lowering the speed limit to 45mph. A meeting will be held finalizing the plans.

\*Discussion was on possibly renting brush chipping/cutting equipment or sharing the equipment cost with another township.

\*Signs for ATV/UTV routes are in the process of being put up

\*Striping will be completed within 1-2 weeks on Rangeline Rd, County Line Rd, Spring Lake Rd, and West Washington Rd.

\*Pat Grohskopf reported some ditches in their area that need cleaning. Pete will check where it is and determine if it is Town Meeme's or Town Hermann's responsibility.

\*New truck is being repaired by a company from Calumet County

\*Pete got two loads of gravel and dumped them in the back area to be used as needed.

**Recycling & Transfer Station:** \*A motion was made by Dennis Graf and seconded by Henry Langenhahn to charge \$5 for miscellaneous electronics. Motion carried

\*10,000 stickers will be ordered.

\*Signs for cardboard breaking down are working

\*Ongoing concerns with hiring; electronic sign will be changed to take off adult help and just indicate help needed

**Valders Ambulance Service:** August's electronic report is available upon request.

**Fire Departments:** A motion was made by Henry Langenhahn and seconded by Susan Kracht to approve the budgets from Ada and Howards Grove. Motion Carried
