Notice is hereby given that a special town meeting of the Town of Meeme, Manitowoc County, Wisconsin, will be held in the town at the Town Hall, 15318 CTH X, Kiel, WI., 53042 on Monday, the 14th day of November, 2022 immediately following the completion of the Public Hearing on the proposed 2023 town budget which begins at 6:30 p.m. for the following purposes:

1. To approve the total year 2023 highway expenditures pursuant to section 81.01(3) of Wisconsin Statutes.
2. To consider the adoption of a resolution by the electors at the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under Wis. Stat. § 66.0602, specifically a proposed tax levy which would exceed the allowable town tax levy for 2022, *before* adjustments, by 10.041%, for a dollar increase of \$34,218.
3. To approve the 2022 total town tax levy (to be collected in 2023), pursuant to Wis. Stat. § 60.10(1)(a).
