

TOWN OF MEEME DOG LICENSING INFORMATION

WHO NEEDS A DOG LICENSE:

Every person who owns, harbors, or keeps a dog more than five (5) months of age on Jan. 1, or five (5) months of age within the license year shall annually, or within 30 days from date such dog becomes five (5) months of age, pay the dog license fee and obtain a license as provided by the provision of Chapter 174.052 of the Wisconsin Statutes and Town of Meeme Ordinance 12.01

HOW DO I GET A LICENSE:

Complete entire application and return with a **separate check** for the correct fee for total of all dogs being licensed. When mailing or dropping off an application, include a self addressed, stamped business size envelope for your new certificate/s and dog tag/s.

REQUIRED:

State law requires each dog over five (5) months of age to be vaccinated against rabies by a veterinarian. **A copy of the rabies vaccination for each dog from the veterinary clinic showing the expiration date and vaccine manufacturer and serial number of vaccine is required.** Do not send your dogs vaccine history or an invoice from your office visit. This will delay you from receiving your dog license. Failure to provide the required documentation will prevent your dog from being licensed.

LICENSING DEADLINE:

April 1, or within 30 days of acquiring a licensable dog.

LATE FEE:

\$25 for the first dog, \$10 for each additional dog filing fee for failure to license by deadline will be charged and must be sent with license fee.

NO LONGER HAVE A DOG:

Notify treasurer in writing to be removed from list.

- A **Certificate of Rabies Vaccination** from veterinarian is STATE REQUIRED for obtaining a dog license. Not a health report summary. If you have misplaced your rabies certificate, your veterinarian can re-issue.
- This completed application.
- Your check payable to: Town of Meeme **After April 1st- Add a late fee of \$25 for first dog and \$10 for each additional dog.**
- Enclose a stamped self-addressed business size envelope to receive tag/s, license/s, and return of your vaccination certificate/s.
